Resolution Recognizing Stone School Cooperative Nursery Inc. as a Civic Nonprofit Organization Operating in Ann Arbor for the Purpose of Obtaining a Charitable Gaming License To obtain a charitable gaming license under Michigan law, a nonprofit organization is required to submit a resolution from its local governing body recognizing it as a community-based organization.

Stone School Cooperative Nursery Inc. is a 501(c)3 civic nonprofit organization offering play-based learning to children 3-6 years of age, primarily focusing on kindergarten readiness by providing a family accessible learning community.

Passage of the attached resolution will allow the Stone School Cooperative Nursery Inc. to hold a future poker tournament. Passage of this resolution is required in order to obtain final approval from the Charitable Gaming Division of the Bureau of State Lottery for this event and any future events. Whereas, Stone School Cooperative Nursery Inc. has requested that it be recognized as a nonprofit organization operating in the community for the purpose of obtaining a charitable gaming license; and
