WHEREAS, The City of Ann Arbor hosts myriad recreational sports leagues at our various facilities, which are enjoyed by residents and non-residents alike on a daily basis; and

WHEREAS, The safe enjoyment of our public spaces is a top priority for our dedicated parks staff, who engage in basic emergency medical training so they may provide support to patrons in need should events call for it; and

WHEREAS, On Saturday, January 12th, 2019, Eddie Kulczycki was playing in one of the City's recreational hockey leagues and experienced a medical emergency that rendered him unconscious during game play; and

WHEREAS, City of Ann Arbor employees Kelsey LaHaye, Kayla Auer, Gabby Peck, as well as USAA Hockey referee Paul Krolick, were able to provide emergency medical attention to Mr. Kulczycki, while their efforts were joined by recreational hockey league players Matt Kennison, David Goyer and Robert Garcia, and supported by Josh Landefeld and Bill Meeks; and

WHEREAS, The quick decision making actions taken by this group of individuals may very well have saved Mr. Kulczycki's life; and
