Resolution to Appoint Michael Pettigrew as the City of Ann Arbor City Treasurer The attached resolution provides for the appointment of Michael Pettigrew as the Ann Arbor City Treasurer, effective August 19, 2019.

Mr. Pettigrew is currently serving as the Interim City Treasurer and participated in a recruiting process that included outside candidates. Mr. Pettigrew has served as the City's Deputy Treasurer (Assistant Treasury Services Manager) since September 2008, and was recommended to be Treasurer from the recruiting process.

Staff recommends that Mr. Pettigrew be appointed the permanent City Treasurer.
