Resolution to Approve the Collective Bargaining Agreement between the City of Ann Arbor and Ann Arbor Police Officers Association Effective January 1, 2020 - December 31, 2022 Human Resources Services recommends approval of the new Collective Bargaining Agreement between the City of Ann Arbor and the Ann Arbor Police Officers Association.

Highlights of the negotiated agreement include:

- 1) Three (3) year agreement
- 2) A 2.5% wage increase for all members effective January 1 of each year of the contract;
- 3) An increase to the uniform and equipment allowances by \$100 each on an annual basis; and
- 4) Many beneficial operational changes, including but not limited to additional flexibility in the Chief's ability to schedule training, manage specialty assignments, and administer the disciplinary process.

City Administration recommends approval of the attached Resolution to approve the January 1, 2020

- December 31, 2022 Collective Bargaining Agreement negotiated between the City and the Ann Arbor Police Officers Association.

Whereas, The parties have reached a settlement on a new agreement on March 12, 2020, which includes a three year term (January 1, 2020 to December 31, 2022); and

Whereas, The Interim City Administrator recommends approval of the negotiated agreement;
