RESOLVED, That the publication of Ordinance 20-27 shall be made by the following summary:

Ordinance 20-27 - An Ordinance to Amend Sections 5.24, 5.29.2, 5.33.2, 5.35.2, 5.36.2 and 5.37 of Chapter 55 (Unified Development Code) Of Title V of The Code Of The City Of Ann Arbor - Sign Regulations, updates and amends regulations for signs in the City of Ann Arbor. The proposed amendments implement content-neutral sign regulation, clarification of sign area calculation, new sign definitions, while generally maintaining comparable amounts of allowed signage to the current regulations.

The effective date of the Ordinance is 10 days after publication.
