Resolution to Approve the January 28, 2021 Recommendation of the Board of Insurance Administration to Deny the Claim and Subsequent Appeal Filed by Claimant Sujata Purohit for a Sewer Backup Claim in the Amount of \$13,100 (CC040-20)

This memorandum and resolution request approval of the Board of Insurance Administration's January 28, 2021 recommendation to deny the claim and appeal filed by Claimant Sujata Purohit. Sujata Purohit submitted a claim against the City to the Board of Insurance Administration in the amount of \$13,100 for a sewer backup. The Board of Insurance Administration denied the claim on the basis of governmental immunity. Claimant Sujata Purohit subsequently appealed the decision to the Board of Insurance Administration. After hearing Sujata Purohit's appeal at its January 28, 2021 meeting, the Board of Insurance Administration recommended the denial of this appeal on the basis of governmental immunity.
