**Resolution to Accept an Easement for Public Right-of-Way from Traver Lakes Community Maintenance Association (8 Votes Required)**

Whereas, Traver Lakes Community Maintenance Association, a Michigan nonprofit corporation, is the owner of property commonly known as Private Commons No. 1 in Traver Lakes Subdivision No. 1, Ann Arbor, Michigan 48105, described at Liber 1493, page 643 of Deeds, Washtenaw County Records; and

Whereas, Traver Lakes Community Maintenance Association has signed a grant of easement for public right-of-way as shown on the attached map shown and described on the attached map:

SIDEWALK EASEMENT DESCRIPTION BEGINNING AT THE INTERSECTION OF THE SOUTH LINE OF TRAVER BLVD. AND THE WEST LINE OF NIXON ROAD; THENCE S01°35'54"E 35.00 FEET ALONG THE WEST LINE OF NIXON ROAD; THENCE N57°40'24"W 53.91 FEET TO THE SOUTH LINE OF TRAVER BLVD.; THENCE N82°07'57"E 45.00 FEET TO THE POINT OF BEGINNING. BEING APART OF PRIVATE COMMONS NO. 1 OF TRAVER LAKES SUBDIVISION NO. 1 AS RECORDED IN LIBER 20 OF PLATS PAGES 33-39, OF THE WASHTENAW COUNTY RECORDS, CITY OF ANN ARBOR, MICHIGAN.
