Resolution Setting a Public Hearing on the Application of Sartorius BioAnalytical Instruments, for an Industrial Facilities Exemption Certificate in Industrial Development District No. 2021-001 The attached resolution provides for action to set a public hearing on April 4, 2022 on the application of Sartorius BioAnalytical Instruments ("Sartorius"), for an industrial facilities exemption certificate in Industrial Development District 2021-001, established by the City of Ann Arbor on March 7, 2022.

State law and City Council policy require that a public hearing be scheduled upon receipt of application for an industrial facilities exemption certificate in an established development district. Sartorius filed an exemption certificate with the City Clerk on March 8, 2022.

Sartorius is requesting a 12-year abatement on up to \$54,587,000 of real property site improvements and up to \$8,943,000 of personal property.

Whereas, Pursuant to Public Act 198 of 1974, as amended ("Act"), after a duly noticed public hearing on January 3, 2021, the Ann Arbor City Council established Industrial Development District No. 2021-001;

Whereas, Pursuant to the Act, Sartorius BioAnalytical Instruments filed an application with the City Clerk for an Industrial Facilities Exemption Certificate for all real property improvements to be constructed and new personal property to be acquired and installed within Industrial Development District 2021-001;
