Resolution to Approve Grants of Easement for Gas Pipeline to DTE Gas Company at Virginia Park and Veterans Park (8 Votes Required)

DTE is conducting capital maintenance of its gas infrastructure as part of its ongoing Gas Main Renewal Program. These easements cover areas of existing gas pipeline infrastructure for which no easement presently exists. DTE's construction schedule necessitates these easements being in place the week of August 15.
