Resolution to Approve University Inn Development Agreement, 2424 E. Stadium (CPC approved the site plan: Approval - 8 Yeas and 0 Nays)

Approval of this resolution will enable execution of the University Inn Development Agreement.

## **Petition Summary:**

- The Site Plan proposes to construct a 4-story residential building totaling approximately 215,000 sq ft and housing 185 dwelling units. An existing 7,716 sq ft office building facing E Stadium remains. Primary access to the site is off E Stadium and Manchester Road which leads to approximately 185 below grade parking spaces. This development contains commercial and office zoning and approval is subject to combining three parcels.
- A development agreement has been prepared for a \$115,625 Parks contribution.

The City Planning Commission, at its meeting of August 3, 2022, approved the site plan and recommends approval of this development agreement.
