Whereas, Ann Arbor Forest Ave Properties KP6, LLC, a Delaware limited liability company, is the owner of property commonly known as 721 S. Forest Avenue, Ann Arbor, Michigan 48104 by virtue of the deeds recorded in Liber 5532, Page 710 of Deeds, Washtenaw County Records; and

Whereas, Grantor has signed a grant of easement for water main and appurtenances as described below and on the attached survey as Water Main Easement No. 2:

Commencing at the South 1 /4 corner of Section 28, Town 2 South, Range 6 East, City of Ann Arbor, Washtenaw County, Michigan; thence South 87 degrees 50 seconds 59 minutes West 594.98 feet along the centerline of Hill Street, as monumented; thence North 00 degrees 00 seconds 00 minutes East 352.15 feet along the centerline of South Forest Avenue, as monumented; thence North 90 degrees 00 seconds 00 minutes East 33.00 feet to the North West corner of Lot 9, Block 5, of R.S. Smith's Second Addition To The City Of Ann Arbor, as recorded in Liber 48 of Deeds, Page 40, Washtenaw County, Michigan and Point of Beginning; thence North 89 degrees 44 minutes 09 seconds East 172.38 feet along the North line of said Lot 9; thence South 00 degrees 15 minutes 51 seconds East 31.32 feet; thence South 89 degrees 44

minutes 09 seconds West 66.84 feet; thence North 45 degrees 15 minutes 51 seconds West 3.00 feet; thence North 00 degrees 15 minutes 51 seconds West 19.19 feet; thence South 89 degrees 44 minutes 09 seconds West 76.05 feet; thence South 00 degrees 15 minutes 51 seconds East 15.00 feet; thence South 89 degrees 44 minutes 09 seconds West 27.48 feet; thence North 00 degrees 00 minutes 00 seconds East 25.00 feet along the East right-of-way line of said South Forest Avenue to the Point of Beginning.

RESOLVED, That the City of Ann Arbor hereby accepts this grant of easement.
