Resolution to Approve a Legal Services Agreement with Rosati, Schultz, Joppich & Amtsbeuchler, PC Relative to City Projects Requiring the Acquisition of Easements or Other Property Interests (\$150,000.00)

Attached for your review and approval is a resolution to approve a legal services agreement with Rosati, Schultz, Joppich & Amtsbeuchler, PC in the amount of \$150,000.00 for legal services relative to City projects requiring the acquisition of easements or other property interests.

The City has a number of active and upcoming capital improvement projects which will require that the City obtain easements or other property interests, and in some instances, this may include the exercising its authority of eminent domain and condemnation litigation.

There are many unique and specialized legal issues involved in the acquisition of easements and other property interests for public projects and condemnation litigation.
