Resolution to Approve a Purchase Order to New World Systems for the Logos.net Financial System Annual Software Support and Maintenance Agreement (\$64,040.00)

Attached for your review and action is a resolution to approve the annual software support and maintenance agreement with New World Systems for the City's financial system software used for budgeting, invoicing, accounts payable, financial tracking and reporting for FY2011 in the amount of \$64,040.00.

The Logos.net application has been instrumental in allowing business units to systematically manage and control spending. The integration allows for monthly reporting and workflow routing for approvals of accounts payable invoices, accounts receivable, purchases, etc. The budget software has allowed employees, administration, and management to track, process, manage, and review the budget from the beginning of the budget planning process through the approval of the new budget. It is imperative to maintain the agreement with New World Systems to receive application updates, and maintain support.
