On March 11, 2011, a hearing was held pursuant to the provisions of Section 436.1501(2) of the Michigan Compiled Laws, and in accordance with Chapter 109 of the Ann Arbor Code of Ordinances on the City Treasurer's objection to renewal of the License based on Section 9:79(1) (b) of the Ann Arbor City Code (delinquent taxes for 2009). Whereas, There being no other grounds for objection to renewal made by the City Administration or the City Liquor License Review Committee under Section 9:79 of the Ann Arbor City Code;
