Resolution to Approve a Purchase Order to Most Dependable Fountains, Inc. for Thirteen ADA Compliant Drinking Fountains (\$49,087.00)

Attached for your review and approval is a resolution to authorize a purchase order to purchase 13 ADA compliant drinking fountains from Most Dependable Fountains, Inc. for a total of \$49,087.00.

In 2007, the City started switching to Most Dependable Fountains (MDF) drinking fountains that were ADA compliant. These fountains have an exclusive design and are not sold elsewhere. The MDF drinking fountains are designed to withstand the extreme circumstances that public drinking fountains have to endure. Most Dependable Fountains, Inc. is the only drinking fountain manufacturer using a solid stainless steel bubbler. Most Dependable Fountains, Inc. is the sole supplier of all MDF products.

All of the City's new drinking fountains are from MDF and it is beneficial to continue to standardize the drinking fountains. Of the 13 drinking fountains, six will replace drinking fountains within the DDA area. The others replace drinking fountains in city parks.

Most Dependable Fountains received Contract Compliance approval on April 7, 2011.

Funds are available in the Public Services Area, Field Operations Service Unit, Park Operations FY 2011, General Fund and Park Maintenance and Capital Improvement Millage operating budgets. Prepared by: Craig Hupy, P.E., Field Operations Unit Manager

Whereas, The Public Services Area, Field Operations Service Unit have available funds for this purchase in the approved FY 2011, Field Operations Unit, Park Operations' operation and maintenance budget;

Whereas, In 2007 the City started switching to Most Dependable Fountains (MDF) drinking fountains that were ADA compliant;

Whereas, The MDF drinking fountains are designed to withstand the extreme circumstances that public drinking fountains have to endure;

Whereas, The Most Dependable Fountains is the only drinking fountains manufacturer using a solid stainless steel bubbler;

Whereas, All of the City's new drinking fountains are from MDF and it is beneficial to continue to standardize the drinking fountains;

Whereas, Most Dependable Fountains, Inc. is the sole supplier of all MDF products;

Whereas, Six of the new fountains will replace drinking fountains within the DDA area and the seven will replace drinking fountains in city parks; and

Whereas, Most Dependable Fountains received Contract Compliance approval on April 7, 2011;

RESOLVED, That City Council approves the purchase the drinking fountains from Most Dependable Fountains, Inc. in the amount of \$49,087.00;

RESOLVED, That the City Administrator be authorized to issue a purchase order in the amount of \$49,087.00 to Most Dependable Fountains, Inc; and

RESOLVED, That City Council authorizes the City Administrator to take necessary administrative action to implement this resolution.
