An Ordinance to Amend Chapter 55 (Zoning), Rezoning of 1.1 Acres from TWP (Township District) to R1A (Single-Family Residential District), Betke Property, 2562 Newport (CPC Recommendation: Approval - 9 Yeas and 0 Nays) (Ordinance No. ORD-11-12)

This ordinance will zone this property to R1A (Single-Family Dwelling District), now that the property has been officially annexed into the City. The proposed zoning is consistent with the adjacent zoning, the surrounding land uses, and the City's Master Plan. The City Planning Commission, at its meeting of December 7, 2010, recommended approval of the request. Ann Arbor Township just recently released the property, thereby allowing completion of the annexation.

The City of Ann Arbor ordains:
